

# MID-OHIO CHRISTIAN CO-OP

## RELEASE OF LIABILITY, ASSUMPTION OF RISK, AND HOLD HARMLESS AGREEMENT

### 2026–2027 School Year

Mid-Ohio Christian Co-op (“MOCC”) is a homeschool cooperative ministry that operates on the property of the Licking County Church of God. Participation in co-op activities includes inherent risks that cannot be completely eliminated.

By signing this agreement, the undersigned parent(s)/guardian(s) acknowledge and agree to the following:

## 1. Assumption of Risk

I understand that participation in Mid-Ohio Christian Co-op activities may involve certain risks, including but not limited to:

- Slips, trips, and falls
- Injuries during classes, recess, sports, field trips, or activities
- Accidental contact with equipment, furniture, playground items, or other participants
- Illness exposure
- Transportation-related risks during off-site events
- Other unforeseen accidents or injuries

I voluntarily assume all risks associated with participation in MOCC activities for myself and my child(ren).

## 2. Release of Liability

On behalf of myself, my spouse, my child(ren), heirs, representatives, and assigns, I hereby release, waive, discharge, and hold harmless:

- Mid-Ohio Christian Co-op
- Its board members, officers, volunteers, teachers, coordinators, and representatives
- Licking County Church of God
- Any property owners or facilities used by MOCC

from any and all liability, claims, demands, damages, costs, expenses, actions, or causes of action arising out of or related to any injury, illness, loss, or damage that may occur while participating in MOCC activities or while on church/co-op grounds, whether caused by negligence or otherwise, to the fullest extent permitted by Ohio law.

### **3. Medical Authorization**

In the event of a medical emergency, I authorize MOCC representatives to obtain emergency medical treatment for my child if I cannot be reached immediately.

I understand that I am solely responsible for any medical expenses incurred.

### **4. Insurance Responsibility**

I understand that Mid-Ohio Christian Co-op does not provide medical insurance coverage for participants. I certify that my family maintains appropriate medical insurance coverage or accept full financial responsibility for any medical expenses.

---

### **5. Parent Responsibility & Supervision**

I understand that Mid-Ohio Christian Co-op is a cooperative organization and not a drop-off program. Parents/guardians remain responsible for the supervision, behavior, and safety of their children at all times unless their child is directly under the supervision of an assigned teacher or volunteer.

---

### **6. Compliance With Rules & Safety Procedures**

I agree to follow all MOCC policies, emergency procedures, safety guidelines, and directions given by board members, teachers, volunteers, or church staff while participating in co-op activities.

Failure to comply with policies or safety expectations may result in removal from activities or membership.

## 7. Photo & Media Release

YES, I grant permission for photographs/videos of my child(ren) to be used in MOCC publications, social media, promotional materials, and the website.

NO, I do not grant permission.

## 8. Acknowledgment

I have carefully read this Release of Liability, Assumption of Risk, and Hold Harmless Agreement and fully understand its contents. I understand that by signing this document, I am waiving certain legal rights on behalf of myself and my child(ren).

I sign this agreement voluntarily and intend for it to be legally binding.
